Sub: Permission to Rajkot Homoeopathic Medical College, Jainalh Petrol Pump Gondal Road, Rajkot-360002, Gujarat to start new MD (Homoeopathy) course in 04- subjects namely Organon of Medicine, Homoeopathic Materia Medica, Repertory and Practice of Medicine with 06 seats each for the academic session 2021-22 under Section 12A of HCC Act, 1973 - regarding.

Sir,

As Central Government by notification, constituted a Commission, to be known as the National Commission for Homoeopathy, to exercise the powers conferred upon, and to perform the functions assigned to it, under NCH Act 2020. As per section 59 (2) of NCH Act, 2020, following has been stated:

“Notwithstanding the repeal of the Homoeopathy Central Council Act 1973, the educational and medical standards, requirements and other provisions of the Homoeopathy Central Council Act, 1973 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder: Provided that anything done or any action taken as regards the educational and medical standards and requirements under the enactment under repeal and the rules and regulations made thereunder shall be deemed to have been done or taken under the corresponding provision of this Act and shall continue in force accordingly unless and until superseded by anything or by any action taken under this Act”.

As per provision in the Act, Medical Assessment and Rating Board for Homoeopathy has been constituted with the mandate to grant permission to the existing and new medical institution of Homoeopathy. Inspection to issue Letter of Permission (LOP) was conducted on 18.11.2021.

2. After examining the guide list provided by the University and considering the teaching faculty, MARBH has decided to issue **Letter of Permission (LoP) to start new MD (Homoeopathy) course in 04 subjects namely Homoeopathic Materia Medica, Repertory, Practice of Medicine, Organon of Medicine with 06 seats each in Rajkot Homoeopathic Medical College, Jainalh Petrol Pump Gondal Road, Rajkot-360002 under section 12A of HCC Act, 1973 for the academic session 2021-22.**

3. All admissions in Post graduate course shall be through AIA-PGET only. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government.
4. The category wise list of selected candidates may be informed to the Medical Assessment and Rating Board for Homocopathy after the process of admission is completed. Any admissions carried out other than AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board as per rules.
5. The college has to comply with the full requirements of Minimum Standard Requirement Regulations, 2013 for conducting the course.
