Sir/Madam,

I am directed to refer to the Ministry's letter No. L-14014/19/2019-EP(1) dated 21.05.2019 related to admission matter for the academic year 2019-20, intimating certain requirements to be fulfilled by the college for consideration of permission for the academic session 2020-21.

2. Further, refer to the CCIM's letter No. Ref. 26-99/2020-Ay. dated 24.11.2020 forwarding therewith recommendation of the college to the Central Government based on thorough examination of the visitation report Part-I, indemnity bond, affidavit & latest details of teaching, non-teaching and hospital staff submitted by the college along with the assessment report, as the physical verification by conduction of inspection could not be carried out in view of present COVID-19 pandemic situation for the A.Y. 2020-21. On examining the same in terms of Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", provisions under the IMCC Act, 1970, relevant regulations made thereunder, it is found that the College is fulfilling notified and approved criterion for granting Conditional Permission for UG (BAMS) course.


3. It has, therefore, been decided by the Central Government to **grant Conditional Permission to Parul Institute of Ayurved & Research, P.O. Limda, Tal. Waghodia, Dist. Vadodara-391760, Gujarat** for conducting **100** seats in UG (BAMS) course for the academic session 2020-21 under Section 13C/13A of the IMCC Act, 1970, subject to the following:

- i. The fulfillment of conditions as specified in the Undertaking/Indemnity bond submitted by the college
- ii. The college shall submit an undertaking in form of affidavit duly notarized within one month explaining the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the Colleges/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provident Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.

4. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of 100 UG (BAMS) seats shall be treated as all India quota. The counseling for seats under all India quota shall be conducted by respective counseling authority of State/UT Government as designated by Central Government vide letter F.No.L.11011/02/2020-EP (1) dated 26.10.2020 for A.Y. 2020-21 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. **The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for all India quota or the students admitted thereunder.**
5. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under IMCC Act & Regulations made thereunder.
6. Discrepancies, if any, may be immediately brought to the notice of Board of Governors, CCIM and the Central Government.
7. The following requirements should be fulfilled by the college by 31<sup>st</sup> December, 2020 to get permission for the session 2021-22:
- (i) all the Requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
  - (ii) all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda); and
  - (iii) all the requirements under the provisions of the IMCC Act, 1970 and relevant Regulations made thereunder should be fulfilled *in toto*
8. The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to CCIM under intimation to this Ministry. The CCIM will verify that the conditions have been fulfilled by means of an inspection and submit a report along with its assessment in this matter to the Ministry of AYUSH for considering the permission matter from the academic session 2021-22.



Sir/Madam,

I am directed to refer to this Ministry's order No.R.12011/17/2016-EP (IM-1) for 2017-18 dated 17.11.2017 related to admission matter for the year 2017-18 intimating to develop the requisite infrastructure for 2<sup>nd</sup> professional for consideration of the case for the 2018-19 sessions.

2. The CCIM had carried out an inspection of the institution on 07.02.2018 and re-visited on 31.05.2018 & 01.06.2018 to reassess the available facilities of teaching and practical training as well as to verify the compliance submitted by the college and forwarded its recommendations and report to the Ministry. On examining the same, it was observed that the Web based computerized central registration system, Functional Clinical Laboratory, X-ray, ECG & USG and Aadhaar based Geo location enabled attendance system for teaching staff, non-teaching staff, hospital staff, as per RMS, 2016 were not available. Therefore, under provisions of the first proviso to sub-section (5) of Section 13A of the IMCC Act, 1970, an opportunity of hearing was granted to the college on 16.08.2018 to present the case.

3. The observation of hearing Committee based on submission made by the college representatives during hearing and recommendations & visitation report of the CCIM have been carefully examined in terms of the “Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals)

Regulations, 2016, provisions under the IMCC Act, 1970, relevant regulations made thereunder and as per approved Standard Operative Procedures (SOPs) for the UG/PG course(s) for consideration of grant of conditional permission for UG (BAMS).

4. It has therefore, been decided by the Central Government to **grant of conditional permission** to the **Parul Institute of Ayurved & Research, P.O. Limda, Tal. Waghodia, Dist. - (ii) all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda); and
- (iii) all the requirements under the provisions of the IMCC Act, 1970 and relevant Regulations made thereunder should be fulfilled *in toto*.

The fulfillment of the conditions attached to the permission given above may be made within the time period specified and compliance report should be submitted to the Ministry of AYUSH endorsing a copy to the CCIM also. In continuation to the Ministry's letter of even No. dated 16.05.2017 wherein a Letter of Intent was issued to the aforesaid university to establish a new Ayurveda college with respect to the proposal submitted to the Central Government as cited above, I am directed to say that after careful consideration of the recommendations & report of the CCIM in terms of criteria as specified in the Regulations 3 and 10 of the Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016, provisions under the IMCC Act, 1970, relevant regulations made thereunder and as per approval of the Hon'ble MoS (IC), Ministry of AYUSH for the UG/PG course(s) for grant of conditional permission for the academic session 2017-18 vide Ministry's letters No.R.11011/03/2017-EP (IM-1) dated 12.06.2017; permission of the Central Government is hereby granted to the **President, Parul University, P.O. Limda, Tal. Waghodia, Dist. Vadodara – 391760, Gujarat** to start new Ayurveda College in the name of **Parul Institute of Ayurved & Research, P.O. Limda, Tal. Waghodia, Dist. **Sub: Grant of conditional permission to the Parul Institute of Ayurved & Research, P.O Limda, Tal. Waghodia, Distt. Vadodara-391760, Gujarat (Inst. ID. AYU0469) with 100 seats in UG (BAMS) course for the academic session 2021-22 under section 28/29 of NCISM Act 2020 and relevant regulations thereunder-reg.**

Sir/Madam,

With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provisions of National Commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act, 1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-section (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) has been dissolved. Now, in exercise of the powers conferred by sub-section (3) of the section 1 of the said Act, the Central Government notified that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021. In view of the above the Central Government constituted the Autonomous Boards with effect from 11th June, 2021 and as per regulation 59 (2) of The National Commission for Indian System of Medicine ACT, 2020, Medical standards, requirements and other provisions of the Indian Medicine Central Council Act, 1970 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder.

Further, the provision of concerned regulations which are inconsistent with the provision of NCISM ACT 2020 shall not be applicable.

2. However, GOI, Ministry of AYUSH vide its letter no. L.14011/3/2020-EP (1) dated 26.03.2021 and 15.04.2021 issued Relaxation/support policy for ASU&S colleges in unprecedented times of COVID-19 pandemic for the academic session 2021-22 and the permission for the academic year 2021-22 of the ASU&S colleges will be considered on the basis of part-I visitation proforma submitted by the college provided that the college shall submit an undertaking & indemnity bond, stating that they shall fulfill respective requirements in terms of required teaching and training facilities specified in the relevant regulations throughout the academic year".

Further, in view of above, the college has been assessed on the basis of Relaxation policy issued by the Ministry of AYUSH and on examining in terms of Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", Indian Medicine Central Council (Post Graduate Ayurveda Education) Regulations, 2016, provisions under the NCISM Act, 2020 and relevant regulations thereunder, it is found that the College is fulfilling notified and approved criteria for Granting Conditional Permission for UG (BAMS) course for A.Y. 2021-22.

3. Therefore, it has been decided by the President, Medical Assessment and Rating Board for Indian System of Medicine **to grant Conditional Permission to Parul Institute of Ayurved & Research, P.O Limda, Tal. Waghodia, Distt. Vadodara-391760, Gujarat (Inst. ID. AYU0469) for conducting 100 seats in UG (BAMS) course for the academic session 2021-22** subject to the following conditions:-
  - I. The fulfillment of conditions as specified in the Undertaking/Indemnity bond submitted by the college.
  - II. The college shall submit an undertaking in the form of affidavit duly notarized within one month explaining the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the Colleges/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provisions Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.
4. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of 100 UG (BAMS) seats shall be treated as all India quota. The counseling for seats under all India quota shall be conducted by respective counseling authority as designated by Central Government for A.Y. 2021-22 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NCISM for all India quota or the students admitted thereunder.
5. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.
6. Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
7. The following requirements should be fulfilled by the college by 31st December, 2021 to get permission for the session 2022-23:
  - (i) all the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
  - (ii) all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda);
  - (iii) all the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be fulfilled in toto; and
  - (iv) all the requirements of the Indian Medicine Central Council (Post Graduate Ayurveda Education) Regulations, 2016 for grant of permission to PG courses.



8. The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission from the academic session 2022-23.
9. This is issued with the approval of Competent Authority.
