IMPORTANT INSTRUCTIONS

A. The admission will be based as mentioned below:

1. Online Written Test
 - a. Research Methodology – 50 Marks (1 hour)
 - b. Specialization/Branch Subject – 50 Marks (1 hour)
 2. Viva consisting of 100 marks in the following manner
 - a. Presentation on proposed research topic – 50 Marks
 - b. Personal Interview – 50 Marks
- Students who have secured 50 % marks in the entrance test are eligible to be called for the proposal presentation and interview.
 - The merit list will be prepared based on the performance in both (1) and (2) above.

B. EXEMPTION FROM ENTRANCE EXAMINATION:

- 1) The Candidate/s who have qualified UGC-NET/SLET/GATE/GPAT/CSIR (JRF/SRF)/Teaching Fellowship/M.Phil. Programme in relevant discipline or are UGC/CSIR/RGNF/DST inspire, NBHM fellows etc. shall be exempted from the entrance examination during the period of the validity of concerned test.
- 2) For the candidates who possess a minimum of 5 years of teaching/research experience and applying for admission to programmes with Master's Degree in Medical Sciences (such as MD/MS) under Faculty of Medicine will be exempted from Entrance Examination. **However, the candidate exempted from entrance examination are**

required to give presentation on the proposed research topic and appear for the personal interview.

C. As per UGC regulations 2022, Ph.D. through Part-time Mode will be permitted, provided all the conditions stipulated in UGC regulations are fulfilled. Candidate shall have to mandatorily furnish “No Objection Certificate” issued by competent authority in the organization where the candidate is employed, clearly stating that:

- i. The candidate is permitted to pursue Ph.D. studies on a part-time basis.
- ii. His/her official duties permit him/her to devote sufficient time for research.
- iii. If required, he/she will be relieved from the duty to complete the course work.

 - UG Marksheets of all the semesters and Degree Certificate
 - PG Marksheets of all the semesters and Degree Certificate
 - A copy of Aadhar Card
 - Caste Certificate (if applicable)
 - M. Phil Marksheet and Certificate (if applicable)
 - Any other document based on which exemption from entrance examination is sought (if applicable)
 - NOC from organization in which currently employed (original copy)
 - Two passport size photographs
- Migration Certificate (original copy) can be submitted within one month of the conduct of the orientation program.
- The process of fees payment by selected candidates shall be completed on or before commencement of semester and Orientation Program. Fees can be paid through Cash/Online mode.
- Fee once paid will neither be refundable nor transferrable.
